Apply for VA Education Benefits on VONAPP at <http://vabenefits.vba.va.gov/vonapp>, if you have not already done so. (Ch. 30/33/1606/1607 use VA Form 22-1990. Ch. 35 use VA Form 22-5490.)

Copy of Certificate of Eligibility (COE) -Student receives from VA as a result of completing VONAPP.

Copy of DD214 (Member 4)(Ch. 30, 33 & 1607), or copy of current Military ID (if active duty). Not required for Transfer of Entitlement.

Copy of Notice of Basic Eligibility (NOBE) for Ch. 1606. A copy of the VA Certificate of Eligibility may be submitted in lieu of the NOBE.

Change of Program or Place of Training Form (Ch. 30/33/1606/1607 use VA Form 22-1995. Ch. 35 use VA Form 22-5495.) May be completed on VONAPP at <http://vabenefits.vba.va.gov/vonapp>, or with PDF documents at [VBA-22-1995](#) or [VBA-22-5495](#).
